Abstract

Introduction

In writing scientific articles, references is a must. By referring to the appropriate references, the paper could be considered as the scientific one or not. Since references is one of the main parts of the scientific articles, the writer must be careful in choosing the books or journal articles as the reference and manage them into References.

According to (Anderson & Poole, 1998), References is "A bibliography for a written assignment is an alphabetic list of all source material to which reference has been made". The followings are the essential information required for all references:

- 1. author's surname and initials and year of publication
- 2. the name of the article and/ or journal or book
- 3. the imprint (publisher and place of publication)

They are many types of scientific articles, some of them are conference paper, academic journal paper, and book(Sujatna, 2014). The similarity of the three types above is References. The three types has References as one of the main parts. References is usually attached in the last part of the paper. The References consists of the books, academic journal articles, conference paper (proceeding) or even the web sites containing the information quoted by the writer of the paper. Sometimes, some of the writers separated the References into Book References, Academic Journal Articles References, and Web Sites.

It is a common problem that the writers sometimes have difficulty in managing their books, academic journal articles, conference, or web sites in their paper. They usually manage them manually. As the result, in avoiding the typing mistakes, the writers should check their References many times, and it could make the writers frustrated.
